• R-45-2023: Proclaim "Distracted Driving Crackdown" April 1 - 30, 2023

Whereas, distracted driving is a serious, life-threatening practice that is preventable; and

Whereas, distracted driving can result in injuries and deaths to all road users (motorists, pedestrians and bicyclists); and

Whereas, distracted driving occurs when drivers divert their attention away from the task of driving to focus on another activity instead; and

Whereas, from 2011-2020 distracted driving-related crashes resulted in 32,000 deaths on our nation's roads; and

Whereas, in New Jersey distracted driving was listed as a contributing circumstance in 50-percent of all motor vehicle crashes from 2016-2020; and

Whereas, the State of New Jersey will participate in the nationwide *Distracted Driving 2023 Crackdown* from April 1 - 30, 2023 in an effort to raise awareness and decrease driver distraction through a combination of enforcement and education; and

Whereas, the national slogan for the campaign is *UDrive*. *UText*. *UPay*; and

Whereas, a reduction in distracted driving in New Jersey will save lives on our roadways;

Therefore, be is resolved that Sea Girt Borough declares its support for the *Distracted Driving 2023 Crackdown* both locally and nationally from April 1 - 30, 2023 and pledges to increase awareness of the dangers of distracted driving.

WHEREAS, the Borough of Sea Girt has achieved "Tree City USA" status by meeting the program's four requirements: a tree board or department, a tree-care ordinance, an annual community forestry budget of at least \$2 per capita and an Arbor Day observance.

3. OPEN DISCUSSION:

Council President Anthony commented there will be an Arbor Day Ceremony on Friday, April 28th at the Sea Girt Elementary School at 2:00 pm. She also recognized 2023 Earth Day and the following volunteer projects: Crescent Park Tree Plantings; Edgemere Park initial prep work for upcoming pollinator garden project and Sea Girt Station removal of English Ivy and other invasive plants as well as placement of wood chips. On April 19th Council President Anthony and Mike Matthews attended the 2023 Invasive Species Conference and noted Sea Girt is following the current scientific research and best practices as they pertain to the management of our parks and open spaces. The Sea Girt Conservancy will be meeting next week to vote on the RFP for the installation of the deer fencing at Edgemere Park. The Sea Girt Conservancy with the approval of the borough is also applying for a grant from NJ Audubon Society toward the purchase of bird houses at Edgemere and Crescent Parks.

Councilman Zakin and Mayor Fetzer both thanked Council President Anthony for her efforts at Edgemere Park and Station Park.

A. Introduction - Ordinance No. 03-2023: The Mayor to read the said Ordinance by Title:

AN ORDINANCE AUTHORIZING THE MUNICIPAL CLERK TO ACT AS THE ISSUING AUTHORITY TO APPROVE RAFFLE AND BINGO LICENSES IN THE BOROUGH OF SEA GIRT, MONMOUTH COUNTY

BE IT ORDAINED by the Borough Council of the Borough of Sea Girt as follows:

Section 1. N.J.A.C. 13:47-1.1 permits the governing body of a municipality to delegate, by ordinance, authority to a person to approve the granting of raffle and bingo licenses.

Section 2. The Borough Council designates the Municipal Clerk of the Borough of Sea Girt as the person having authority to approve the granting of raffle and bingo licenses pursuant to the terms of N.J.A.C 13:47-1.1.

Section 3. The Municipal Clerk shall file a certified copy of this Ordinance to the Legalized Games of Chance Control Commission.

Section 4. If any part or parts of this Ordinances are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this ordinance.

Section 5. All ordinances or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.

Section 6. This ordinance shall become effective immediately upon its final passage and publication as required by law.

B. Introduction – Ordinance 04-2023: The Mayor to read the said Ordinance by Title:

GENERAL CAPITAL ORDINANCE PROVIDING FOR THE REHABILITATION OF CRESCENT PARK AND BELL PLACE TENNIS COURTS IN AND BY THE BOROUGH OF SEA GIRT, IN THE COUNTY OF MONMOUTH, NEW JERSEY, AND APPROPRIATING \$100,000.00

WHEREAS, the Mayor and Council of the Borough of Sea Girt in the County of Monmouth, New Jersey have determined that the Tennis Courts located at Crescent Park and Bell Place are in need of rehabilitation; and

WHEREAS, the Borough has in excess of \$100,000.00 in its General Capital Improvement Fund; and

WHEREAS, the Sea Girt Board of Education has agreed to reimburse the Borough of Sea Girt \$24,500.00 for the Bell Place Tennis Court Rehabilitation upon completion of the project; and

WHEREAS, the Sea Girt Board of Recreation has agreed to reimburse the Borough of Sea Girt up to 50% of the Crescent Park Tennis Court rehabilitation with a not to exceed amount of \$32,000.00 upon completion of the project;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Sea Girt, in the County of Monmouth, State of New Jersey, as follows:

- Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general capital improvement to be undertaken in and by the Borough of Sea Girt, in the County of Monmouth, New Jersey. For the improvements or purposes described in Section 2, there is hereby appropriated \$100,000.00. Said sum being inclusive of \$100,000.00 from the General Capital Improvement Fund.
- Section 2. The improvement hereby authorized to be undertaken consist of the rehabilitation of both the Crescent Park and Bell Place Courts to include crack repair, resurfacing and line painting, together with all purposes necessary, incidental or appurtenant thereto, all as shown on and in accordance with contracts, plans, specifications or requisitions therefore on file with or through the Borough Clerk, as finally approved by the governing body of the Borough.
- Section 3. The 2023 capital budget of the Borough will conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Borough Clerk and is available there for public inspection.
- Section 4. The Borough Officials and representatives are hereby authorized to do all things necessary to accomplish the purpose of the appropriation made herein.
 - Section 5. This ordinance shall take effect as provided by law.

• R-51-2023 - Approve Settlement Agreement of The Matter Captioned in The Matter of the Application of The Borough of Sea Girt, Docket No. Mon- L-2312-2020

UPON MOTION of Councilman Clemmensen, seconded by Councilman Zakin, carried, that the following Resolution be and the same is hereby adopted:

WHEREAS, the Borough was the subject of a Mount Laurel exclusionary zoning suit filed in the Superior Court of New Jersey entitled <u>501</u> Washington Blvd, LLC, <u>503</u> Washington Blvd., LLC, <u>Sea Girt Fifth Avenue LLC</u>, <u>Sitco Sea Girt, LLC v. Borough of Sea Girt, Borough Council of Sea Girt, and Sea Girt Planning Board</u>, (the plaintiffs shall be collectively referred to as the "Developer"), Docket No. MON-L-000102-20, seeking to compel the Borough to provide a realistic opportunity for the construction of housing affordable to low and moderate-income households and their fair share of the housing region's need for such housing, (the "Builder's Remedy Action"); and

WHEREAS, the Borough instituted a declaratory judgment action entitled In the Matter of the Application of the Borough of Sea Girt, Superior Court of New Jersey, Law Division-Monmouth County, Docket No. L-2312-2020 (the "Mt. Laurel Litigation) wherein the Borough sought a declaration as to its affordable housing obligation and the opportunity to develop a plan to meet its constitutional obligation to provide for its fair share of affordable housing so as to prevent additional builder's remedy lawsuits; and

WHEREAS, the Borough and the Borough Planning Board entered into a Settlement Agreement with the Developer in the Builder's Remedy Action and the Court approved the Settlement Agreement after conducting a Fairness Hearing on June 3, 2021 finding it fair, reasonable and adequately protecting the interests of very low, low and moderate-income households in the region; and

WHEREAS, the Fair Share Housing Center ("FSHC") has been recognized by the Supreme Court in Mt. Laurel IV as an interested party that may participate as a matter of right in all cases filed by municipalities seeking a declaration as to their affordable housing obligation, including the Borough of Sea Girt; and

WHEREAS, to avoid the large expense and risk of trial as to fair share methodology and the proposed compliance mechanisms required to meet the Borough's fair share obligation, the Borough and FSHC has reached a settlement to resolve the Mt. Laurel Litigation and they wish to memorialize the terms in the form of a Settlement Agreement; and

WHEREAS, the Borough Council believes it is in the best interest of the Borough to resolve the Mt. Laurel Litigation with Fair Share Housing Center to satisfy its constitutional obligation to provide for its fair share of affordable housing from 1987-2025 and to obtain immunity from builder's remedy litigation through July 1, 2025.

NOW, THEREFORE, IT IS HEREBY RESOLVED, by the Borough Council of the Borough of Sea Girt, in the County of Monmouth and State of New Jersey, that it hereby approves the Settlement Agreement in the Mt. Laurel Litigation, and it hereby authorizes the mayor to execute the Settlement Agreement in a form acceptable to the Borough Attorney and the Borough's Special Affordable Housing Counsel.

6. COUNCIL REPORTS

Councilman Clemmensen reported bulk pickup is May 8th. He encourages all residents to consider wearing bike helmets.

Councilman Downey thanked Mr. Gant for his efforts on the employee salary resolution. A replacement for Janeen Yodakis is underway; he thanked Charlie Hill for his service of twenty-two years; DPW has two new hires starting in May. Chicago Boulevard Sanitary Sewer Improvements Phase I is complete.

Councilman Perry reported the Finance Committee have been working diligently on the 2023 budget; the plan is to introduce the budget on May 10th. He thanked Janeen Yodakis for her dedication and service to Sea Girt Recreation; Motors on Main is on May 7th and Big Band Sentimental Journey is playing on June 21st. Please visit the website for all upcoming events and details.

Councilman Zakin had no report.

Council President Anthony reported on Buildings and Grounds; Jim Gant commented The Borough is looking into other options to upgrade the Borough Hall fire safety matters; the borough had approved a bond ordinance in the amount of \$600,000.00 for important upgrades. Jim Gant also reported that there have been workers from Off Shore Winds within the borough and he expressed to them the need to communicate with Administration when they have work scheduled in order to better coordinate with borough officials and be able to share information with residents. Councilman Zakin applauds the mayor and professionals for being vigilant and clear on expectations regarding Off Shore Wind Energy. She also cautioned everyone to be aware of ticks and their hazards.

Mayor Fetzer reported the labor negotiations committee met with the Department of Public Works on their salary negotiations contract and will met again next month. The library is moving towards the creation of a capital plan and it is suggested to meet with the Borough to discuss parameters and to synchronize the plan. The Fire Department will have their annual smoke house drill at the Monmouth County Fire Academy. The Parker House replaced their doors which is a major improvement from a fire department perspective.

7. ADMINISTRATIVE REPORT

Jim Gant reported The Fifth Avenue Improvements project will begin soon; efforts are being made to avoid summer traffic issues while paving Fifth Avenue from Beacon Boulevard to Washington Boulevard. Tennis courts will be resurfaced soon, temperatures need to be consistently above 70 degrees for a certain crack repair bond to be applied. Monmouth County Parks announced grant opportunities which we could apply for to address our Monument Park area at The Plaza. Mr. Gant suggested to council the hiring of a 5G Consultant to protect the interest of the borough from a professional standpoint who understands lease agreements and public contracts law. He thanked Janeen Yodakis for her efforts and her impact on recreation. The purchase of a recent mini excavator has been put to good use for difficult digging holes to plant trees on Carriage Way.
