Mayor Fetzer noted the next Coffee with the Mayor is November 2nd at the Fire House from 4:00-5:30; he noted at the next meeting he would like to have a presentation/open discussion on Wind Turbines.

5. UNFINISHED BUSINESS:

ORDINANCE No. 10-2023: The Mayor read the said Ordinance by Title:

AN ORDINANCE CREATING THE POSITION OF POLICE CHAPLAIN FOR THE SEA GIRT POLICE DEPARTMENT

WHEREAS, N.J.S.A. 48:14-141 provides that the governing body of the Borough of Sea Girt by Ordinance may provide for the appointment of one or more Chaplains to the Police Department; and

WHEREAS, Police Chaplains serve an integral role in providing comfort to members of the Police Department as well as the public and aid in community policing; and

WHEREAS, the Council finds it in the best interest of the Borough of Sea Girt;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Sea Girt that as follows:

- 1. **POSITION CREATED**. The position of Police Chaplain for the Borough of Sea Girt Police Department is hereby created in accordance with 40A:14-141. The position will be a volunteer position. The position of Chaplain shall be under and subject to the control of the Chief of Police.
- 2. **QUALIFICATIONS**. Any person appointed as Chaplain shall be an ordained clergyman in good standing in the religious body from which he/she is selected. The Chaplain shall have basic training and shall be a certified Police Chaplain credentialed in accordance with the rules and regulations of the Borough of Sea Girt Police Department and shall be qualified in accordance with N.J.S.A. 40A:14-141.
- 3. **DUTIES OF POLICE CHAPLAIN**. The duties of Police Chaplain shall include, but not be limited to assisting the Borough of Sea Girt Police Department in death notifications, station house adjustments and any other duties that may be assigned by the Chief of Police.
- 4. **RANK AND SALARY**. Any person appointed as Chaplain shall serve in that capacity without Rank or Salary.
- 5. **TERM OF OFFICE**. A person appointed as Chaplain shall serve for a period of one (1) year from

- date of appointment and shall continue to serve in that capacity until he/she is either terminated or reappointed with the recommendation of the Chief of Police.
- 6. **APPOINTMENT**. The Chief of Police may recommend to the mayor persons that he/she believes meet the qualifications of N.J.S.A. 40A:14-141 as well as the rules and regulations of the Borough of Sea Girt Police Department with reference to Chaplains, if any. All applicants for the position of Chaplain shall be reviewed by the Chief of Police and The Public Safety Committee to determine his/her qualifications in accordance with this Ordinance and shall make recommendations to the mayor regarding the appointment as Chaplain. The mayor shall appoint Chaplains in accordance with this Ordinance with the advice and consent of Borough Council.

There were no comments from the public. **UPON MOTION** of Councilman Clemmensen, seconded by Councilman Perry, carried, the public hearing was closed.

WHEREAS, *R.S.* 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and,

WHEREAS, the Local Finance Board has promulgated *N.J.A.C.* 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New

Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "General Comments" and "Recommendations"; and,

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "General Comments" and "Recommendations" as evidenced by the group affidavit form of the governing body attached hereto; and,

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to *N.J.A.C.* 5:30-6.5; and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and.

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of *R.S.* 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Sea Girt hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

Seq.,) as well as most advantageous based upon Price and Other Factors (N.J.A.C. 5:34-4); and

WHEREAS, it is the recommendation that the Borough enter into an agreement for services under competitive contract with V-Comm LLC, 2540 US Highway 130, Suite 101, Cranbury, New Jersey, 08512, for a period of five (5) years under the terms and tenets as set forth in the competitive contract procurement CC# 23-02.

 R-148-2023: Authorize the Borough of Sea Girt's Civil Rights Policy with Respect to all Officials, Appointees, Employees, Prospective Employees, Volunteers, Independent Contractors, and Members of The Public that come into Contact with Municipal Employees, Officials and Volunteers

UPON MOTION Council President Anthony, seconded by Councilman Zakin, carried that the following Resolution be and the same is hereby adopted:

WHEREAS, it is the policy of Sea Girt Borough to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of Sea Girt Borough has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BE IT ADOPTED by the Governing Body of the Borough of Sea Girt that:

- **Section 1:** No official, employee, appointee or volunteer of the Borough by whatever title known, or any entity that is in any way a part of the Borough shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough's business or using the facilities or property of the Borough.
- **Section 2:** The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough to provide services that otherwise could be performed by the Borough.
- **Section 3:** Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.
- **Section 4:** The Borough Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.
- **Section 5:** No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.
- **Section 6:** The Borough Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.
- **Section 7:** The Borough Administrator shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.
- **Section 8:** At least annually, the Borough Administrator shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Borough. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Borough's web site.
- **Section 9:** This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Borough in order for the public to be made aware of this policy and the Borough's commitment to the implementation and enforcement of this policy.

7. COUNCIL REPORTS

Councilman Clemmensen reminded residents that garden trash pickup is on Thursday; bulk pickup is October 16th; DPW is short staffed and he asked residents to clear storm drains if possible; he credited the DPW for their care and maintenance of our equipment; he also reminded residents to wear helmets while on bicycles.

Councilman Perry thanked Amy Spera and Jim Gant for their efforts on the audit and budget. October 20th is the Halloween Hayride from 6:00 -8:00 pm at the firehouse, please bring a treat to share. Sea Girt Lifeguards and Recreation are hosting Photos with Santa on November 3rd between 1:00-3:00 pm at Beacon & Ocean Avenue; he noted Rec Basketball has gone by the way side and he encourages kids grade 3 through 8 to sign up on our website. October 18th council and employees of the borough areal participating in the Coast Habitat for Humanity effort.

Councilman Zakin reported October 14^{th} is the Antique Car Show between 10:00 am to noon at the Plaza along with the Fire House Food Drive.

Councilman Downey thanked Mr. Gant for his efforts hiring two new employees for DPW and in Administration.

Councilwoman Richman reported the weather ended the beach season due to storms; beach staff is working diligently in the fall season in preparation for the winter; the borough was approached by students Hope and Charlotte Perry to bring cleanup stations to the borough's beach entrances with bags that are easily accessible for using to pick up beach debris and then disposing the debris in the garbage cans year-round. Clean Ocean Action beach sweep is October $21\text{sst}\ 9 - 12\text{:}30$ am.

Council President Anthony reported she attended a community stakeholder meeting including Sea Girt Borough Council, Administration and Management as well as Sea Girt's Shade Tree Commission, Recreation Commission, Sea Girt Holly Club and The Sea Girt Conservancy on behalf of opportunities of improvements for Sea Girt's parks, beaches and open spaces. Council President Anthony congratulated Tim Harmon, Jim Gant and Amy Spera for their efforts obtaining a grant from the Monmouth County Open Space Grant Program which will be applied to the Memorial Park Plaza area. Jim Gant noted he received notice of the matching grant award last week and is excited for the improvements to area in 2024. She also thanked those involved in the planting of the dune grasses along The Terrace and The Fish & Wildlife for the donation of planting materials.

Mayor Fetzer reminded residents of the Firehouse Food Drive on October 14th at the Plaza. He noted residents asked the borough to contact the county to reduce speed limit on 8th Avenue; Chief Macko requested the county to prepare a traffic study of the area which resulted in a reduction of the speed limit to 25 mph as well adding a cross-walk; the county is also adding a pedestrian walkway at Washington Boulevard and Second

Avenue. He further thanked the participants of the Ordinance Review Committee; many ordinance changes were discussed to make improvements to the languages and allow easier enforcement.

8. ADMINISTRATIVE/POLICE REPORT

Jim Gant reported he emailed a DPW survey to all residents and there was a great response; the survey will provide responses and allow the borough a better understanding of the needs in the community.

Chief Macko thanked those who attended Coffee with a Cop last week; Officers will be trained next week on their Conducted Energy Devices; The Governor's Review is held at the NGTC on October 29th at 11:00 am; the public are allowed to watch from fence. He met the Monmouth County Engineering Department to discuss a crosswalk at Washington and Second Avenue; he spoke to the reduced speed limit on 8th Avenue; he further spoke to the improvement at Rt. 71 & Baltimore painted crosswalk design and cross walk at Rt. 71 and Beacon Boulevard.
