**WHEREAS,** Patrolman Joule, Special Officer Ciufo and Special Officer McCrossan immediately began CPR and initiated the use of the Automated External Defibrillator, which required three cycles before the victim responded; and,

**WHEREAS**, the victim was then transported to the hospital by Manasquan First Aid, during which time the victim was conscious, alert and speaking and after a short time, walked out of the hospital; and,

**WHEREAS**, the survival of the victim is directly attributable to the training and use of proper techniques by Patrolman Joule, Special Officer II Ciufo and Special Officer I McCrossan.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council wish to commend Patrolman Joule, Special Officer II Ciufo and Special Officer I McCrossan for their exemplary actions and that we extend our appreciation on behalf of the entire community for their selfless acts of service to the people of Sea Girt.

**WHEREAS**, the Borough of Sea Girt, County of Monmouth, State of New Jersey (the "Borough") after public hearing and consideration of the recommendations of the Borough's Land Use Review Committee, desires to amend its Land Use Code to update Paragraph 17-7.1, Zoning Permit Application fees.

John Ward, Member of Planning Board explained concerns expressed by Planning Board and suggested a sliding scale for the fees; Councilperson Rotolo noted fees seem onerous as suggested by Mr. Ward; Councilperson Morris added fees also fund the necessary inspections of the projects, not just plan review. Councilperson Meixsell noted that he did not think the Borough permitted the installation of above ground pools; Council President Fetzer said that fees should be reflective of their complexity.

There being no further comment and **UPON MOTION** of Councilperson Mulroy, seconded by Councilperson Morris, carried, the public hearing was closed.

Mayor Farrell requested a motion to adopt the said Ordinance; there was no motion, therefore, the Ordinance died on the table.

## AN ORDINANCE TO AMEND AND SUPPLEMENT SECTION 17-5, GENERAL REGULATIONS – ADDING SUBSECTION 17-5.2, REGULATIONS FOR THE CONSTRUCTION OF A BASEMENT BENEATH AN ACCESSORY OR PRINCIPAL STRUCTURE, OF CHAPTER XVII, ZONING, OF THE BOROUGH CODE OF THE BOROUGH OF SEA GIRT, COUNTY OF MONMOUTH

**WHEREAS**, the Borough of Sea Girt, County of Monmouth, State of New Jersey (the "Borough") after public hearing, desires to amend its Land Use Code to revise its regulations related to the construction of a basement beneath an accessory and/or principal structure; and,

**NOW, THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Sea Girt, County of Monmouth, State of New Jersey (the "Borough"), as follows:

**SECTION 1.** Chapter XVII of the Borough Code of the Borough of Sea Girt, entitled "Zoning" in particular Section 17-5 entitled "General Regulations", subsection 17-5.2, Basement Beneath an Accessory or Principal Structure:

A. Definition: For purposes of this section, the following definition shall prevail:

"Basement" or "cellar" shall mean a story having more than fifty (50%) percent of its height below finished grade

B. Section 17-5.2 shall be added as follows:

A grading and drainage plan shall be submitted with the permit application which plan shall include:

- a. a full depth soil boring to the seasonal high groundwater table as prepared by a fully licensed Professional Engineer.
- b. location of existing and proposed grades.
- c. groundwater conditions.
- d. Construction activities shall be undertaken in accord with all governmental agencies including, but not limited to, the regulatory requirements of the Freehold Soil Conservation District which include, but are not limited to, the following: Stone Tracking Pad; Perimeter Silt Fence; Hay Bale Inlet Protection; Zero Silt Runoff from Residential Property; No off Site Discharge of Construction Dewatering Activities.
- e. Bottom elevation of the basement or cellar shall not be less than two (2) feet above the seasonal high groundwater elevation, as defined by January 1 through April 1 of each year.

**SECTION 2**. Enforcement. It shall be the duty of the Code Enforcement Officer to enforce the provisions of this Chapter. All complaints shall be filed with the Code Enforcement Officer.

**SECTION 3.** Violations and penalties. Any person who shall violate any of the provisions of this Chapter shall, upon conviction, be subject to the penalties as provided in Chapter 1, Section 1-5 entitled "General Penalty." Each day of violation shall constitute a separate offense.

**SECTION 4**. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 5.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 6**. This Ordinance shall take effect upon publication in an official newspaper of the Borough, as required by and in conformance with law.

**SECTION 7.** A copy of this Ordinance shall be filed with the Monmouth County Planning Board, pursuant to <u>*N.J.S.A.*</u> 40:55D-16 and adjacent municipalities.

**Section 2.** All amendments to said fees and penalties by this Ordinance shall be effective on\_January 1, 2018.

**Section 3.** If any articles, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared severable.

**Section 4.** All other Ordinances in conflict or inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior Ordinances, the provisions hereof shall be determined to govern.

**Section 5.** This Ordinance shall take effect twenty (20) days after adoption and final publication as required by law.

## AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER XVII, ZONING, SECTION 17-2, "DEFINITIONS" AND SECTION 17-7, "CERTIFICATES AND PERMITS" OF THE LAND USE VOLUME OF THE BOROUGH OF SEA GIRT CODE, IN THE BOROUGH OF SEA GIRT, COUNTY OF MONMOUTH

**WHEREAS**, the Borough of Sea Girt, County of Monmouth, State of New Jersey (the "Borough") after public hearing and consideration of the recommendations of the Borough's Land Use Review Committee, desires to amend and supplement its Land Use Code to update Paragraph 17-2, Definitions and Paragraph 17-7.1, Zoning Permit Application fees.

**NOW, THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Sea Girt, County of Monmouth, State of New Jersey (the "Borough"), as follows:

**SECTION 1.** Chapter XVII of the Borough Code of the Borough of Sea Girt, entitled "Zoning" in particular Section 17-2 entitled "Definitions" is hereby amended and supplemented as follows: *Wells: b. Window* Wells are permitted in the front, rear and side yards only when the following conditions are met, to wit: 1) the height of the window wells must be sixteen (16") inches or less above the natural elevation; and 2) no window well may be installed in an area designated as a required setback

**SECTION 2**. Chapter XVII of the Borough Code of the Borough of Sea Girt, entitled "Zoning" more particularly Paragraph 17-7.1 entitled "Zoning Permits", is hereby supplemented as follows:

New Subsection b. Annual Permit and Fee Required in conjunction with New Construction and Construction of Additions over 750 square feet in area on property accessed from the unpaved roads in the Borough, that is, The Terrace west of First Avenue to Fifth Avenue and Carriage Way from Trenton to Philadelphia Boulevards: \$5,000, payable each year.

New Subsection c. Permits will be valid for one year from date of issue and must be renewed annually no less than thirty (30) days prior to the expiration of the current permit and until a final Certificate of Occupancy is received from the Construction Office. The renewal of the permit requires the payment of a renewal fee, \$5,000.

New Subsection d. The proceeds of all permit fees collected by the Borough pursuant to Subsection "b" will be reserved for future maintenance of the unpaved roads.

**SECTION 3**. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 5**. This Ordinance shall take effect upon publication in an official newspaper of the Borough, as required by and in conformance with law.
