# 7. COUNCIL REPORTS

Councilman Clemmensen reported there is a Halloween curfew in place for the upcoming weekend; Chief Macko has allowed for participation in "No Shave November and December" to raise money for Tunnels to Towers Foundation; donations will be accepted at the Sea Girt Police Department. Leaf pickup is ongoing.

Councilman Perry reported Pictures with Santa is taking place on Beacon Boulevard Beach between 10am-12pm on October 29<sup>th</sup>; Veterans Breakfast is November 12<sup>th</sup> between 8am to 10am at The Firehouse; please contact Recreation Director Janeen Youdakis to volunteer. There will also be tree plantings at Edgemere Park between 9am-12pm; please register on community pass to volunteer. November 5<sup>th</sup> between 9am-4pm is the Sea Girt Craft Market at the Elementary School. Mr. Perry thanked all volunteers and borough employees involved in the Haunted Hayride; it was a wild success.

Councilman Zakin had no report.

Councilwoman Richman reported Shore Community Alliance along with the elementary school is hosting Red Ribbon Week and teaming up against drugs; Coffee with a Cop is October 29<sup>th</sup> between 9-11am at Shore Pour; Spring Lake Heights, Sea Girt and Manasquan Police will attend. She thanked the volunteers for their efforts during the Clean Ocean Action Beach Sweep; it was a big success.

Councilman Downey reported a review in underway of the Borough's Personnel Manual as well as an employee survey.

Council President Anthony reported there will be a Tree Health Pruning Safety Seminar in addition to a Forestall Health Seminar by The Sea Girt Conservancy, The Sea Girt Borough and the Shade Tree Commission on November 19<sup>th</sup> between 10am – 12pm; a venue has not been set, but a flyer will be distributed soon with details to register. Work is still being done along The Terrace regarding The Tree-of-Heaven trees and Spotted Lantern Flies. There are discussions with the US Fish and Wildlife regarding beach back dune on the east side of The Terrace with a plan and implementation of dune grass being temporarily planted in replacement of the Japanese Knotweed.

Mayor Fetzer reported there was a small incident at the water plant with a broken valve/leak which was quickly taken care of by DPW operators. The Strategic Plan for the Library is still being reviewed by the Library Trustees. The Fire House is hosting their annual food drive on October 29<sup>th</sup> a truck will be stationed at the Plaza.

Mayor Fetzer further commented there had been discussions regarding the Recreation Trust Account, The Recreation Commission and The Borough alleging the Borough was misleading the public; he noted the allegations are not true and the recreation trust will fund the additional paddle tennis court; DPW, Police and The Fire Company support many activities in town throughout the year; funds are not allocated under a particular budget item. The Sea Girt 5K files a tax form with the State which is public record and is not included in the borough audit; a portion of The Recreation Commission as well as other borough services are part of our audit.

# 8. ADMINISTRATOR REPORT

Mr. Gant reported he is pleased with new updated zoom platform; it was a needed operation to continue our public meetings and provide a better experience to the residents at home.

Chief Macko reported that on Saturday at the Police Headquarters between 10am-2:00pm is The National Prescription Drug Take Back Day which aims to provide a safe, convenient, and responsible means of disposing of prescription drugs. He congratulated Detective Sherman for completing 40 hours of Crisis Innervation Training. He encourages residents leaving their homes for the winter to take advantage of the key box program; please contact the police department to complete a form and your house will be looked after while your away; a house key may be stored at headquarters in case of an emergency. He asked residents to be vigilant and remove key fobs from cars and lock all doors.

# 10. PUBLIC PARTICIPATION ON ANY SUBJECT

Mike Bell, Philadelphia Boulevard, commented on an issue with the borough's mechanical equipment ordinance; he read the mission statement of the Ordinance Review Committee and hopes this will be addressed and resolved.

Anne Britt, Seaside Place commented she is keenly aware of the current events in Sea Girt and is actively involved in the upcoming election; she supports a stronger democracy.

Harvey Richman, Boston Boulevard commended council for their representation at the Governor's Review at the NGTC; he commented it was impressive to see the members on the podium being recognized for their involvement.

Mayor Fetzer noted the Greater Spring Lake Chamber of Commerce will be honoring Frankie Kineavy as 2022 Citizen of the Year Award; the Borough will present a proclamation.

There being no further comments from the public and by consensus, the public hearing was closed at 7:46 PM. WHEREAS, the Borough has defended a lawsuit in Monmouth County Superior Court entitled BRIAN MANLEY, THERESA MANLEY, DENNIS LAUZON and CANDACE KADIMIK vs. The BOROUGH OF SEA GIRT, PARKER HOUSE, et als. related to the operation of the Parker House; and

WHEREAS, the parties have worked collaboratively to resolve the issues which formed the basis of said lawsuit; and

WHEREAS, the governing body has determined that it is in the best interests of the Borough and its residents to resolve the matter amicably despite its denial of Plaintiffs' claims; and

WHEREAS, the parties have come to a resolution of the lawsuit, as memorialized in a consent judgement and settlement agreement, and

WHEREAS, the Borough has committed to the continued enforcement of Borough Ordinances, and to support the Parker House application to allow a pick up/drop off zone for taxis on First Ave., adjacent to the Parker House property, and pick up/drop off for other ride share vehicles on Beacon Blvd., adjacent to the Parker House
