The Virtual Regular Meeting of the Borough of Sea Girt Council was called to order by Mayor Farrell at 7:00 PM on Wednesday, June 24, 2020. Mayor Farrell asked for a moment of silence, after which he led those participating in the Pledge of Allegiance.

- 5. PUBLIC PARTICIPATION ON ANY CONSENT AGENDA ITEM: There were no comments from the public present.
- 6. MINUTES, June 10, 2020 Virtual Regular Meeting

The Clerk advised that the Minutes are not available for approval at this time.

## 7. OPEN DISCUSSION

Councilman Clemmensen commented he is concerned about a recent dune excavation undertaken by a resident(s) without required permits. He noted that the dunes serve an environmental and public safety purpose for the entire community; he also noted that the dune could provide an extra hour of evacuation time in the event of a major storm. He suggested that a letter be sent to our residents from our Engineer and Attorney outlining the procedure to obtain a permit. Mayor Farrell concurred.

Mayor Farrell recognized the efforts of Police Officers Chris Van Brunt, Nick Irizarry and Detective Matt Mason in providing CPR during an emergent situation and saving the life of a friend and resident.

Councilman Mastrorilli commented on the change to the trash and recycling collection without having full council vote; he noted he respects the committee processes, but feels this should have been presented to council for debate and vote. Residents have written to the Borough seeking to have the changes rolled back. He stated that he is willing to move to revoke the changes to the method until the Committee has the chance to review and return with recommendations.

Councilman Begley reiterated the comments made by Councilman Mastrorilli, suggesting that the Borough is reducing services to residents by requiring compliance with the regulations, i.e., clear path to the receptacles or trash/recycling is not picked up. He suggested that additional training is necessary for DPW staff so they can continue the service like Spring Lake does. He also noted that he appreciates the Committee process, but would like further discussion of this.

Council President Fetzer commented that there is backyard pickup, there is no change to that service; he noted that what has changed is the result of homes are being built to the maximum property coverage allowed by our ordinances, limiting the amount of space available to our DPW employees to pick up trash/recycling. He also noted that fencing between properties limits access to rear yards and noted that recycling is a major issue due to the change in county disposal regulations (plastic bags prohibited). He identified one of the major concerns is limiting the possibility of injury to our employees. He also opposed having to open up fences to pick up receptacles.

Mayor Farrell commented that Spring Lake picks up recycling twice a month at the curb throughout the year. Sea Girt is requiring a clear path for DPW staff to access receptacles. The Mayor advised that the recycling center is open 7 days per week for the convenience of residents.

After further discussion, Councilman Clemmensen suggested that Council obtain public comment.

Councilwoman Anthony addressed tree safety concerns along Crescent Parkway near St. Mark's Church; trees have been reviewed by the Shade Tree Committee and Arborist, Bill Brash. Of the nine trees, five have been designated as dangerous and in need of immediate removal; she suggested two phases of removal, one now and one later in the year just before planting the replacement trees. Mayor Farrell responded trees are old and unsafe and should be replaced with new trees. Councilwoman Giegerich noted that it would be more cost effective to remove all the trees at this time, given the short period of time between now and the end of September. By consensus, Council agreed that all the trees should be removed now.

#### 8. OLD BUSINESS

A. **Ordinance No. 09-2020**: They Mayor to read the said Ordinance by Title, advising of its publication in its entirety in the Asbury Park Press on June 13, 2020:

ORDINANCE NO. 09-2020
AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER IV, PARAGRAPH
4-10 TAXIS, AUTOCABS AND VEHICLES HIRED FOR CARRYING
PASSENGERS AND CHAPTER VII, TRAFFIC, PARAGRAPH 7-37 LOADING
ZONE AND 7-38 TAXI STAND OF THE BOROUGH CODE OF THE BOROUGH
OF SEA GIRT, MONMOUTH COUNTY

BE IT ORDAINED by the Borough Council of the Borough of Sea Girt as follows:

**SECTION 1.** Paragraph 4-10.9, Fees is hereby deleted in its entirety.

**SECTION 2.** Paragraph 4-10.19 Taxi Stands shall be amended as follows:

Paragraph 4-10.19 Taxi Stands/Ride Share Drop off or Pick up Zone.

A. No person shall sit, idle, park, or operate in a designated taxi stand/ride share zone for any other purpose except to pick up or discharge passengers. A designated taxi stand may be occupied by a taxi/autocab and driver licensed by the Borough and/or a registered ride share vehicle and driver in accordance with this section. No person shall leave any vehicle unoccupied in any designated taxi stand/ride share zone. The taxi stands/ride share drop off zone shall be utilized strictly for the discharge of passengers during hours as approved annually by the Borough Council. Therefore no taxi/ride share vehicle shall sit, idle or park in a taxi stand/ride share zone during those hours unless patrons are waiting for transportation. No taxi or ride share vehicle shall sit, idle or park in a taxi stand/ride share zone for longer than 10 minutes. A taxi stand/ride share zone shall allow a person the opportunity to find transportation services in an expeditious, unbiased, nondiscriminatory, and courteous manner.

## B. Temporary Taxi Stand/Ride Share Drop off or Pick up Zone.

- 1. In the event of an emergency, or circumstance as described in subparagraph 2, the Chief of Police, or highest ranking police officer on duty in his absence, may designate, on a temporary basis not to exceed 24 hours after said emergency or circumstance arises, the location and size of any taxi stand/ride share drop off or pick up zone\_in accordance with State law.
- 2. The ranking or senior Borough Police Officer on duty may, in the event, the number of people at any location seeking transportation from taxi/autocabs or ride share vehicles creates or may create a safety concern and or may create a disturbance of the peace, may establish a temporary taxi stand/ride share zone at any public location, such temporary taxi stand ride share drop off or pick up zone to be designated by temporary traffic signs or other traffic devices identifying the Temporary Taxi Stand/Ride Share Drop off or Pick up Zone. The provisions of this section applicable to Taxi Stands/Ride Share Drop off or Pick up Zone shall be applicable to Temporary Taxi Stands/Ride Share Drop off or pick up Zone. (Ord. No. 13-2009 § 18; Ord. No. 17-2011 § 6)
- 3. In the event that a temporary alternate pick-up/drop off zone is designated consistent with subsection B(1) or (2), the Chief or ranking officer shall report said emergency or circumstance to the Mayor and Council, and the basis for said action no later than 24 hours after doing so.

# SECTION 3. PARAGRAPH 7-37, LOADING ZONE is hereby revised as follows:

## DELIVERYAND LOADING ZONE.

The location described in this section is hereby designated as the delivery Zone. No person shall park a vehicle in this location during the times indicated other than for the delivery of goods and materials. (Ord. No. 12-2018). During delivery, any delivery vehicle shall have its rear hazard warning flashers engaged (Ord. No. 15-2018), and at least two of its emergency warning triangles placed at the rear of said vehicle, on the east shoulder of First Avenue. Said vehicle shall be temporarily parked as far to the right as practicable so as not to obstruct traffic, but not on the adjacent sidewalk. The vehicle shall remain at this location for only so long as necessary to deliver its goods or materials. The time of deliveries and location are as follows:

(Note: Minimum length for all loading zones is fifty (50) feet. No Loading Zone may be established in any area where it is prohibited to stand or park by statute. N.J.S.A. 39:4-138.)
SECTION 4. PARAGRAPH 7-38 TAXI PARKING is hereby amended and supplemented as

# 7-38 TAXI PARKING/RIDE SHARE DROP-OFF AND PICK-UP ZONE

The locations described are hereby designated as Taxi Parking/Ride Share Drop off and Pick\_Up Zone. No vehicle other than a taxi or a registered ride share vehicle shall be permitted to occupy these locations during the times indicated. (Ord. No. 739 § h.; New; Ord. No. 06-2013).

**UPON MOTION** of Councilman Clemmensen, seconded by Councilwoman Anthony, carried, that the meeting be opened to the public for comments on the said Ordinance only.

Mr. Lou Luglio, retained by Genova Burns, was not able to share his report, but he discussed that in his opinion, the proposed Ordinance doesn't provide enough room to be successful for use by both ride share vehicles and taxis; he feels a more permanent plan needs to be developed; he added another solution is to have a geofence area for the ride share companies to wait for pick up and drop off activity; he added having the taxi and rideshare together is not in the best interest of the residents or patrons.

Mayor Farrell replied that there are no good choices given the existing infrastructure of the Borough.

Councilwoman Giegerich asked Mr. Luglio where the geofence area should be located. Mr. Luglio responded that Beacon Boulevard will not work, but Ocean Avenue could work; he added that from a safety perspective, First Avenue if improved with safety enhancements, should be utilized, understanding that First Avenue is a County road and County approval would be required before being utilized. Councilman Mastrorilli stated that this Ordinance is for one year; he supports use of First Avenue and noted that the First Avenue option will be further discussed after the summer.

Councilman Begley stated this Ordinance isn't just for 2020; it had been discussed at length and will continue further evaluation by professionals and seeking input from residents; we need to have a plan in place that is right for the Borough, residents and for the overall public safety.

Councilman Clemmensen asked Mr. Luglio to share his plan with council members; he agreed to do so.

There were no further comments from the public present and **UPON MOTION** of Councilman Clemmensen, seconded by Councilman Mastrorilli, carried, the public hearing was closed.

## **ORDINANCE NO. 10-2020**

AN ORDINANCE PROVIDING FOR THE RESURFACING OF THE BALTIMORE PARK BASKETBALL COURT AND PROVIDING FOR THE COST THEREOF TO BE APPORTIONED EQUALLY TO THE RECREATION TRUST FUND, 5K DONATION ACCOUNT AND THE CAPITAL IMPROVEMENT FUND OF THE BOROUGH OF SEA GIRT, COUNTY OF MONMOUTH, NEW JERSEY

BE IT ORDAINED by the Borough Council of the Borough of Sea Girt, County of Monmouth, as follows:

Section 1. The Borough Council of the Borough of Sea Girt wishes to undertake various general improvements in the Borough of Sea Girt as listed below:

DESCRIPTION	ESTIMATED COST
Resurfacing and restriping of the Baltimore Park Basketball and	
Shuffleboard Courts	\$35,000.00

**Section 2.** The improvements or services requested as stated above are general improvements or services for general improvements that the Borough may lawfully undertake and the amount appropriated therefor is \$35,000.

**Section 3.** No debt is to be issued for said improvements and the cost of said improvements is to be financed from the funds are presently on hand in the Recreation Trust Fund, 5K Donation account and the Capital Improvement Fund of the Borough.

## Section 4. Repeal, Severability.

- a. All ordinances or parts of ordinances inconsistent herewith are repealed, but only to the extent of such inconsistency.
- b. If any section, paragraph, subparagraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subparagraph, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

This Ordinance shall take effect immediately upon its final passage and publication as required by law.

## E. Resolution No. 117-2020: Authorize Alternate Dates for Sea Girt 5K

**UPON MOTION** of Councilwoman Anthony, seconded by Councilman Mastrorilli, carried, that the following Resolution be and the same is hereby adopted:

WHEREAS, on February 26, 2020, the Borough Council of Sea Girt adopted Resolution No. 45-2020, that authorized an Agreement with the Sea Girt 5K, Inc., a 501(c)3 corporation of the State of New Jersey, for the sponsorship of a 5K race to be held on August 1, 2020; and,

WHEREAS, Sea Girt 5K, Inc. has requested that the date of the event be changed to either September 7 or October 17, 2020 due to the COVID19 pandemic and the resulting restrictions enacted by the Governor to limit the spread of the virus.

# NOW, THEREFORE, BE IT RESOLVED, as follows:

- 1. Sea Girt 5K, Inc. will conduct the foot race to be held on either September 7 or October 17, 2020, not to exceed five kilometers, as well as children's races, live music and activities, if these events are permitted under Executive Orders issued by the Governor;
- 2. Sea Girt 5K, Inc. will provide acceptable insurance and a release to the Borough having the Borough named as additional insured against liability and property damage for the purpose of the event. Sea Girt 5K, Inc. shall deliver to the Borough prior to the event a certificate evidencing minimum coverage in the amounts of one million dollars (\$1,000,000) per occurrence.
- 3. Sea Girt 5K, Inc. will provide evidence satisfactory to the Borough that it is a validly organized not-for-profit corporation of the State of New Jersey and will be so as of the date of the event.
- 4. The Borough of Sea Girt will permit the use of its roadways, provide police, emergency, and public works department assistance and provide insurance under the terms of its general liability insurance policy on the day of the race.
- 5. Sea Girt 5K, Inc. will pay over to the Borough of Sea Girt not less than 90% of the participation fees in the 5K Run/Walk and not less than 90% of the participation fees in the Kids' Races.
- 6. The net proceeds of the entry fees collected by Sea Girt 5K, Inc. after deduction of the expenses set forth in Section 5, above shall be retained by the Sea Girt 5K, Inc. for use and or charitable donations to be made in the sole discretion of Sea Girt 5K, Inc.
- 7. The Sea Girt Noise Ordinance is hereby waived between the hours of 7:30 AM to 8:00 AM, inclusive, on the date of the event.
- 8. The Sea Girt Police Department shall create a 'No Parking' Zone at the Plaza and along Washington Blvd. to Sixth Avenue from Midnight through 12:00 Noon, inclusive, on the date of the event.
- 9. The Sea Girt 5K, Inc. event coordinator shall notify Chief Davenport of the Sea Girt Police Department and Michael McArthur, Manager of the Department of Public Works, not less than 30 days prior to the alternative date finally chosen for the event.

#### 10. ADMINISTRATOR REPORTS

- A. Crescent Parkway Trees (near St. Mark's): The Shade Tree Commission has been monitoring the trees since the initial condition report promulgated by our Forrester in 2017 determined that the trees were compromised (a copy is included with the Agenda). He recently inspected the trees again and found that they are in further decline, with at least one tree considered a "danger" tree requiring immediate removal, a copy of his June 16 message is also attached. The Shade Tree Commission members have also viewed the trees, concur with the determination that they are severely compromised and recommend the removal of all trees this year to minimize the risk to the public in this high-traffic area; a copy of their June 19 message is also attached. Replacement trees will be planted in the fall; per Mr. Brash, recommended replacement tree is white swamp oak, 2-2.5" caliper, 10-12 feet tall. Our tree removal contractor has been notified and we are waiting for a mobilization date.
- **B.** Coronavirus Update: the Governor continues to ease restrictions on gatherings and public activities; non-essential stores are able to open with social distancing observed;
  - a. Baltimore Park field and basketball courts were open on Monday, June 22; the playground remains closed;
  - b. I am happy to report that the Borough filed a timely request with Monmouth County for reimbursement of eligible Phase I expenses under the Coronavirus Relief Fund Program; our application has been reviewed and the payment of \$149,426.54 has been approved.
  - c. Outdoor Dining option Both Emerald Shore, Inc. t/a Harrigan's and CG Jersey, Inc. t/a Fratello's submitted conforming plans as required and were open; there were no issues with their operations. Late on Monday, June 22, CG Jersey, Inc. has submitted a request to utilize Borough property (that is, parking spaces on the east side of The Plaza in front of the existing premises).

## C. Beach:

- a. The Beach is now open full-time through Labor Day:
- b. In compliance with the social distancing requirements of the Governor's Executive Orders, access to the beach may be limited depending if the maximum capacity has been reached; if this is necessary, access may be allowed again as the crowd diminishes;
- c. For their protection and the protection of our staff, beach patrons are urged to wear masks when interacting with our staff and with other patrons;
- d. Daily Badges will be available for purchase from the following locations only during operating hours: the Pavilion at Beacon Boulevard; New York, Philadelphia and Trenton entrances
- e. The Concession will open on or about July 1; eating on the beach remains prohibited;
- D. Public Works Update: The Public Works Committee has met several times to discuss the complaints of residents finding it difficult to follow the sanitation and recycling guidelines that have been approved by the Committee to please maintain clear access to containers on both sanitation and recycling pick-up days this requires residents to either place their containers at the end of the last vehicle parked in the driveway or to park vehicles on the street on pick-up days. This is especially important on recycling pick-up days as the County has changed its rules and will not accept plastic bags with recyclables requiring our staff to lift the containers to dump into the rear of the scooter. Another issue is the limited area between vehicles parked in driveways and homes that has caused inadvertent damage to residents' vehicles while staff is maneuvering the cans to the scooter. Also, due to injuries to our staff resulting from the inability to access containers without obstruction, the Borough's

Negotiating Committee agreed to include this provision (i.e., unobstructed access to containers), to the DPW Collective Bargaining Unit agreement that went into effect on January 1, 2019. The Committee has agreed that these are reasonable requests for the following reasons: 1. to minimize damage to residents' vehicles; 2. reduce potential injury to our staff and 3. reduce the Borough's Workers' Comp claims and costs.

E. Primary Election Update: The Primary Election is scheduled for July 7. Based on new regulations adopted by the Governor, all "active" Republican and Democrat voters will (or should have already received) a mail-in ballot and must vote using this ballot. The ballot must be postmarked by Election Day but will be considered timely and will be counted if it is received by July 14, 2020."Inactive" voters will (or have already) received an Application for a Mail-In Ballot; this must be completed and returned to the County Clerk no later than June 30 in order to receive the ballot. There will be in-person machine voting (hours 6 AM to 8 PM) only for handicapped individuals who will be required to execute an Affidavit affirming that they are unable to vote using the paper mail-in ballot; everyone else will be required to vote using a Provisional Ballot.

# 11. QPA REPORTS (of activity since previous Council Meeting):

- -The Borough continues to purchase necessary personal protective equipment for our employees including masks, gloves, building and equipment sanitizers and other equipment from various vendors to ensure their safety during this on-going crisis;
- -The Borough received four (4) responses to the Request for Proposal for Preparation of a Study to Determine the Feasibility of Expanding the Municipal Building; the summary is provided with the Agenda. The responses have been forwarded to the Buildings and Grounds Committee for their review and a future recommendation.
- 12. COUNCIL REPORTS: Councilwoman Anthony had no report.

Councilman Clemmensen reported as follows:

- Beach is in pristine condition and well maintained:
- The Borough successfully passed the first Monmouth County Regional Health Commission inspection for Public Beach and Lifeguard operations;
- Daily badges sold to date are 6,225 which is approximately 687 more than this time last year;
- Police are doing a fabulous job; unfortunately 2 high-end vehicles were stolen because they were left unlocked; he encouraged residents to secure their property.

Councilman Mastrorilli thanked Police, Fire, Beach and Lifeguards for their efforts during the pandemic.

Councilman Begley reported as follows:

- Thanked Mrs. Carafa for her efforts applying for reimbursement from the COVID-19 Relief Fund Program;
- Thanked the Police and Lifeguards for their efforts;
- OEM no major updates; please continue social distancing.

Councilwoman Giegerich commented that the Library can open on July 6<sup>th</sup> at 25% capacity and our Librarian, Lisa Luke is developing an operational plan; the children's room will remain closed for now.

Council President Fetzer reported as follows:

- Congratulated Mrs. Carafa for her quick processing of COVID-19 reimbursement;
- Water reminded residents to conserve water during the summer months;
- Contract negotiations are going well with H2M; appreciates everyone's patience as we work through this process;
- Dune Breach piping plover is nesting at the north end of the NGTC; we have gone to great lengths to comply with DEP requirements; imperative that people cooperate in our efforts to maintain compliance with DEP regulations.

Mayor Farrell thanked First Responders, Police Officers, Fire Department and DPW for doing a great job.
