#### **ORDINANCE NO. 16-2017**

AN ORDINANCE PROVIDING FOR FUNDS FOR IMPROVEMENTS TO THE DPW CAMPUS AND ADJACENT PROPERTY IN THE BOROUGH OF SEA GIRT AND PROVIDING FOR THE COST THEREOF FROM THE CAPITAL IMPROVEMENT FUND OF THE GENERAL CAPITAL FUND OF THE BOROUGH OF SEA GIRT, COUNTY OF MONMOUTH, NEW JERSEY

**BE IT ORDAINED** by the Borough Council of the Borough of Sea Girt, County of Monmouth, as follows:

**Section 1.** The Borough Council of the Borough of Sea Girt wishes to undertake various general improvements in the Borough of Sea Girt as listed below:

DESCRIPTION OF IMPROVEMENT	ESTIMATED COST
Improvements to DPW Campus and adjacent property	\$25,000.00

**Section 2.** The improvements as stated above are general improvements that the Borough may lawfully undertake and the amount appropriated therefor is \$25,000.00.

**Section 3.** No debt is to be issued for said improvement and the cost of said improvement is to be financed from the funds presently accumulated in the General Capital, Capital Improvement Fund of the Borough of Sea Girt.

# Section 4. Repeal, Severability.

a. All ordinances or parts of ordinances inconsistent herewith are repealed, but only to the extent of such inconsistency.

b. If any section, paragraph, subparagraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subparagraph, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

## **Section 5. Effective Date**

This Ordinance shall take effect immediately upon its final passage and publication as required by law.

C. **Resolution No. 172-2017:** Adopt updates to Borough's Personnel Policies and Procedures Manual as recommended by Labor Counsel:

**UPON MOTION** of Councilperson Mulroy, seconded by Councilperson Rotolo, carried, that the following Resolution be and the same is hereby adopted:

**WHEREAS**, the Borough of Sea Girt adopted Ordinance No. 11-2010 adopting a revised Personnel Policies and Procedures Manual dated May 12, 2010 and said Ordinance authorizes the Borough Council to amend, revise, replace and supplement the Personnel Policies and Procedures Manual by duly adopted Resolution; and,

**WHEREAS**, the Borough Council of the Borough of Sea Girt, pursuant to guidance issued by its Labor Counsel, wishes to revise the existing Personnel Policies and Procedures Manual by including, but not limited to, the following section revisions:

- 1. Changes were made to the Prohibition of Harassment in the Workplace Policy;
- 2. Changes were made to the Employee Dating Policy;
- 3. Changes were made to the Employee Complaint Procedure and Complaint Form;
- 4. Changes were made to the Prohibition of Workplace Violence Policy;
- 5. Changes were made to the Whistleblower Policy and Conscientious Employee Protection Act Notice to Employee;

**NOW, THEREFORE, BE IT RESOLVED** that the Borough of Sea Girt Personnel Policies and Procedures Manual, as revised and dated October 26, 2017, is hereby approved by the Borough Council.

- **BE IT FURTHER RESOLVED** that this manual is intended to provide guidelines covering public service by Borough employees and is not a contract. The provisions of this manual may be amended and supplemented from time to time without notice and at the sole discretion of the Borough Council
- **BE IT FURTHER RESOLVED** that to the maximum extent permitted by law, employment practices for the Borough of Sea Girt shall operate under the legal doctrine known as "employment at will."
- **BE IT FURTHER RESOLVED** that the Administrator and all managerial/supervisory personnel are responsible for compliance with these employment practices. The Labor Attorney shall assist the Administrator in the implementation of the policies and procedures in this manual.

Councilperson Morris reported as follows:

- Library: There are now 878 library cardholders; children's programs are very popular; over 700 items circulated; technical help with teen is offered twice a week; book delivery service available for patrons in need; cookbook club growing; Facebook page has over 200 likes.
- Zoning: 23 projects in review; 5 approved (no permits required); 4 with permits (pools, etc.); 1 referred to Planning Board for variance; 11 under review by Engineer.

Council President Fetzer reported that the next PBA negotiating session is tentatively scheduled for November 20.

Mayor Farrell reported as follows:

- Leaf pickup is through December 15<sup>th</sup>;
- Working with JCP&L on options to address issues of old streetlights several options; can provide catalog for review by other council members; address by spring;
- New garbage cans throughout town, looking at alternatives; remind everyone that public cans are not to be used for disposal of household trash;
- County question recently passed by County voters that raised the open space tax by \$0.0125 cents per \$100 of assessed valuation results in increase of \$297,000 to Borough's taxpayers;
- Suggested that the Borough investigate its options with regard to the Monmouth County Library System as the amount we pay to the County is egregious;

Council President Fetzer noted that there is no direct correlation between the amount paid to the County and discussing the possibility of leaving the County Library System.

Mayor Farrell replied that the school library falls under the Sea Girt Elementary School budget.

Diane Anthony, Brooklyn Blvd., thanked Council, Mayor and Mrs. Carafa for support in the election process; looks forward to working with all departments and Borough Administrator; asked if possible to provide irrigation to the Crescent Park Island to make more colorful; Mayor Farrell responded we already have irrigation.

There being no further comments, and by consensus, the public hearing was closed.
