2. FY2018 CDBG Project Application – public hearing

• The Borough is planning to submit an application for a FY2018 CDBG Grant. Due to the requirements of the Program, the Borough is only eligible to apply for a grant for the removal of architectural barriers (aka ADA Accessibility Improvements). The Sea Girt Citizens Participation Committee met on June 19, 2017 and after reviewing the available options, recommended that an application be submitted to the County for the Project entitled "Removal of Architectural Barriers/ADA Improvements to the Sea Girt Library"; the amount requested is the program's maximum, \$200,000. The project includes a proposed 2,355 sq. ft. addition that will be utilized for Library and Community Programs and also include ADA-accessible restrooms, power-assist doors with ADA-compliant hardware, signage, installation of a sound system with accommodation for the hearing-impaired and improved parking.

Mayor Farrell explained the parameters of the program. Councilperson Morris also noted that the Library is need of updating as far as ADA compliance is concerned and noted that Mrs. Carafa, who is very familiar with the CDBG Program procedures, will complete and submit the Borough's application as required in July, with a presentation before the CDBG Participation Group in September. Councilperson Meixsell asked if matching funds are required; Mrs. Carafa advised that they are not, but the Borough plans to allocate funds to the project. Council President Fetzer asked if proposed improvements will be to the existing structure; Mrs. Carafa answered that retrofitting the existing structure is not cost effective, so a new structure is necessary to make the facility fully ADA-compliant.

UPON MOTION of Councilperson Foley, seconded by Councilperson Mulroy, carried, and by consensus, the meeting was opened to the public for comments on the proposed application only.

Mrs. Kane, Crescent Pkwy., noted that she is excited that the Borough will be submitting the grant application, as the library has been a welcoming and vibrant asset to the Community.

Mrs. Goski, Washington Blvd., asked where the addition would be relative to the existing structure; Mrs. Carafa replied that is will be located to the south of the existing Library structure. There being no further comment and **UPON MOTION** of Council President Fetzer, seconded by Councilperson Morris, carried, the public hearing was closed.

WHEREAS, it is the desire of the Borough of Sea Girt Citizens' Participation Group to recommend that an application be submitted for a FY2018 Community Development Block Grant Program funding for a project to remove architectural barriers at the Sea Girt Library; and,

NOW, THEREFORE, BE IT RESOLVED, after a public hearing thereon, that the Borough Council of the Borough of Sea Girt has approved the project to be known as Removal of Architectural Barriers at the Sea Girt Library and authorized the Community Development Program Representative to submit an application for a FY2018 Community Development Block Grant in the amount not to exceed \$200,000 for the said Project.

7. OLD BUSINESS

A. Ordinance No. 11-2017 – public hearing/possible adoption

The Mayor read the said Ordinance by Title and advised of its publication in its entirety in *The Asbury Park Press* on June 17, 2017:

ORDINANCE NO. 11-2017

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER X, PARKS AND RECREATION, ARTICLE 10-1, MUNICIPAL TENNIS COURTS AND ARTICLE 10-2, PADDLE TENNIS COURTS, TO SET RULES FOR USE OF MUNICIPAL TENNIS AND PADDLE TENNIS COURTS IN THE BOROUGH OF SEA GIRT, MONMOUTH COUNTY

BE IT ORDAINED by the Borough Council of the Borough of Sea Girt as follows:

10-1 MUNICIPAL TENNIS COURTS.

10-1.1 Use by Residents Only.

The tennis courts on Bell Place and Crescent Park are for the use of the residents of the Borough upon registration and the payment of the appropriate fee. Residents may register for an annual, weekly or daily permit; The *members* of the Recreation *Commission*, the officers of the Police Department and other authorized personnel of the Borough may demand, at any time, proof of payment of the permit fee as a condition precedent to the use of the aforesaid tennis courts by any person. (Ord. No. 547 § 1)

- 10.1.1.1 Resident shall be defined as any person owning, residing in or legally renting a residence in the Borough of Sea Girt.
- **10.1.1.2** *Renting* shall be defined as inhabiting a residence located in the Borough for which the property owner has registered for a landlord license and a Certificate of Occupancy for the rental has been issued by the Zoning Official of the Borough.
 - 10-1.2 Replaced in its entirety as shown below
 - 10-1.2 Permit Required; Fees.
 - a. Fees.
 - 1. Annual membership, available to residents only:
 - a. The annual family membership for parents and minor children residing in the same household valid from March 1 to February 28 of the following year: one hundred fifteen (\$115.00) dollars.
 - b. individual membership permit: sixty-five (\$65.00) dollars.

- 2. Weekly permit (valid for a single, seven (7) day period of consecutive days only): \$20.00
- 3. Daily permit fees: ten (\$10.00) dollars per day.
- 4. Permit fees are non-refundable.
- b. Purchase of Permits. All permits shall be purchased using the on-line access and reservation process.
- c. Reservations. Reservation for court time <u>shall be obtained using the on-line reservation system</u>. Holders of an annual permit or purchaser of a weekly or daily permit may make a reservation to play subject to the following rules:
 - 1. Reservations are valid for a maximum of two (2) consecutive hours of play
 - 2. When the application for reservation is made the applicant must furnish the name and address of all players and pay the appropriate fees for all persons not registered for a permit.
 - 3. Prioritization of access:
- 1. Permit holders with a valid reservation shall have priority over permit holders without a reservation;
- 2. Permit holders without a valid reservation shall have priority over those without a valid permit.
- 3. Groups must relinquish the court to those with priority over them. If groups have equal priority, the courts are available on a first-come, first served basis. Two (2) hour maximum play time when others are waiting to play.

10-1.3 Rules and Regulations.

The Recreation <u>Commission</u> of the Borough is authorized to prepare, in writing, reasonable rules and regulations for the use and maintenance of the tennis courts. Rules and regulations shall be available upon request by any resident of Sea Girt and, further, pertinent excerpts of such rules and regulations shall be posted conspicuously at the tennis courts on Bell Place and Crescent Park. (Ord. No. 547 § 3)

- a. Other:
 - 1. Proper tennis footwear is required on the courts at all times.
 - 2. No pets allowed on the courts at any time.
- 3. <u>No skateboarding, roller blading, bicycle riding or other activities allowed on the courts at</u> any time.

10-1.4 Violations and penalties.

Every person, firm, association, organization or corporation violating any provisions of this article or any regulations adopted pursuant thereto shall, upon conviction, be liable to the penalty stated in Chapter 1, General Provisions, Article 1-5 et seq., General Penalty.

10-2 PLATFORM TENNIS COURTS.

10-2.1 Hours of Operation.

The platform tennis court are solely for the use of the residents of the Borough. Non-resident guests are permitted when accompanied by a resident who is a member upon purchase of a daily permit. The platform tennis court may be used between the hours of 8:00 a.m. and 10:00 p.m. daily, except when not in use the court shall be kept locked at all times. (Ord. No. 946 § 1)

10-2.2 Permit Required; Fees.

a. Fees.

- 1. Annual family membership for parents and minor children residing in the same household valid from June 1 to May 31 of the following year: one hundred fifteen (\$115.00) dollars.
 - 2. Annual individual membership permit: sixty-five (\$65.00) dollars.
 - 3. Daily permit: fifteen (\$15.00) dollars.
 - 4. Permit fees are non-refundable.
- b. Purchase of Permits. Annual permits <u>shall be purchased using the on-line access and reservation process.</u>
- c. Reservations. Reservation for court time <u>shall be obtained using the on-line reservation system.</u> Holders of an annual permit or purchaser of a daily permit may make a reservation to play subject to the following rules:
 - 1. When the application for reservation is made the applicant must furnish the name and address of all players and pay the appropriate fees for all persons not holding an annual permit.
 - 2. Persons obtaining a reservation will be given a key to the court fifteen (15) minutes prior to the reserved time. At the conclusion of the reserved time the holder of the reservation shall leave the court and return the key to the lockbox affixed to the exterior of Police Headquarters. In no event may the key be left with succeeding players. If applicable, on leaving the court, lights and heat shall be turned off. Players without a reservation may be bumped by persons with the reservation. (Ord. No. 946 § 2; Ord. No. 2007-20 § 2; New)

d. Violations and penalties.

Every person, firm, association, organization or corporation violating any provisions of this article or any regulations adopted pursuant thereto shall, upon conviction, be liable to the penalty stated in Chapter 1, General Provisions, Article 1-5 et seq., General Penalty.

Mayor Farrell explained the Ordinance and the online registration system. Council President Fetzer asked if the paddle tennis court is locked when not in use; he was advised that it is, and that registered users have an access code when they want to use the court; Councilperson Mulroy noted that he is in favor of implementing the on-line registration system.

UPON MOTION of Council President Fetzer, seconded by Councilperson Mulroy, carried, and by consensus, the meeting was opened to the public for comments on the said Ordinance only.

Mr. Kregg, Boston Blvd., noted that the fee is too low for paddle tennis, as private courts are much more expensive; he also noted that he is in favor of a fee for guests/non-residents. There being no further comment and **UPON MOTION** of Councilperson Foley, seconded by Councilperson Mulroy, carried, the public hearing was closed.

UPON MOTION of Councilperson Rotolo, seconded by Councilperson Mulroy, carried, that the said Ordinance No. 11-2017 be adopted on final reading, directing the Clerk to post and publish as required by law.

9. ADMINISTRATOR REPORTS/DISCUSSION

- A. The Terrace Rehabilitation Project project has been completed with the exception of a few punch list items. As many of you may know and is currently posted, the Borough has reduced the speed limit on The Terrace and Carriage Way from 15mph to 10mph in attempts to reduce the speed which will protect the integrity of the gravel surface. Through recent traffic monitoring, we have come in contact with violators many of whom, unfortunately, are residents, family members or their visitors not in compliance with the new speed limit restrictions. I am asking residents to please remind your family or visitors to abide by the 10mph restrictions on The Terrace so we can get the maximum longevity out of the new improvements. The police department will continue its efforts in monitoring and enforcing the speed limit to ensure public safety which will in turn extend the life of the road. Thank you.
- B. **Beach News** Endangered and threatened species' have nested on North Beach and the surrounding areas; please be cautious when walking in the area so as not to disturb the nests.
