- 2. **PRESENTATION:** Council President Anthony introduced Leeanne Hoffmann who is a volunteer on the The Sea Girt Conservancy Committee whom provided an update to councilmembers on the creation of the Pollinator Garden and improvements at Edgemere Park.
- 3. **CONSENT AGENDA- UPON MOTION** of Councilman Clemmensen, seconded by Councilman Perry, carried, that the following Resolutions be and the same is hereby adopted:

Mayor Fetzer requested the Professional Appointment of H2M Municipal Water and Sewer Engineer be moved to the March 8^{th} council meeting to allow further review the contract.

• R-09-2023: Appoint Dawn Harriman as Redactor, as mandated by Daniel's Law

WHEREAS, there exists a need for the appointment of a redactor for the Borough of Sea Girt to carry out the redaction protection mandated by Daniels Law; and

WHEREAS, Daniel's Law works with the State, county and local government agencies to shield the protected information of Covered Persons as the law defines them from disclosure on those agencies' websites, so that consistent and effective privacy protections are provided to these Persons, who serve the people of the State of New Jersey every day; and,

WHEREAS, the redactor(s) will be registered with the Department of Community Affairs;

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of Sea Girt, County of Monmouth, State of New Jersey that Dawn Harriman is hereby appointed Redactor and Megan Thompson as backup Redactor for matters pertaining to Daniel's Law.

• R-10-2023: Appoint Recycling Coordinator – Trevor Palmer

WHEREAS, the Borough of Sea Girt is desirous of appointing a Recycling Coordinator; and

WHEREAS, the Mayor and Council have determined that Trevor Palmer is qualified for the position of a Certified Recycling Coordinator and will be able to perform the duties of Recycling Coordinator as delineated by statute and in the Borough Code, Chapter 2-33.3, and

NOW, THEREFORE BE IT RESOLVED by the Mayor and council of the Borough of Sea Girt that Trevor Palmer be and her hereby appointed to serve as Recycling Coordinator effective immediately; the stipend for Recycling Coordinator is \$2,000.00.

• R-11-2023: Authorize the Borough of Sea Girt Police Department to enter into a Cooperative Pricing Agreement for the Provision and Performance of Goods and Services with the Township of Cranford

WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, the Cranford Police Cooperative Pricing System (ID # 47-CPCPS), hereinafter referred to as the "Lead Agency" has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services;

WHEREAS, on February 8, 2023 the governing body of the Borough of Sea Girt, County of Monmouth, State of New Jersey duly considered participation in a Cooperative Pricing System for the provision and performance of goods and services;

NOW, THEREFORE BE IT RESOLVED as follows:

TITLE

This RESOLUTION shall be known and may be cited as the Cooperative Pricing Resolution of the Borough of Sea Girt.

AUTHORITY

Pursuant to the provisions of *N.J.S.A.* 40A:11-11(5), the Chief Executive Officer, Amy Spera *is* hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

CONTRACTING UNIT

The Lead Agency shall be responsible for complying with the provisions of the, *Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.)* and all other provisions of the revised statutes of the State of New Jersey.

• R-2023: Authorize Monmouth County Mosquito Control Division to Conduct Aerial Mosquito Control Operations in the Borough of Sea Girt

WHEREAS, the Monmouth County Board of Chosen Freeholders, pursuant to *N.J.S.A.* 26:9-27, *et seq.*, has elected through its Mosquito Control Division to perform all acts necessary for the elimination of mosquito breeding areas and/or to exterminate mosquitoes within the County; and,

WHEREAS, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control and chemical control to exterminate the mosquito population with the County of Monmouth; and,

WHEREAS, prior to conducting aerial dispensing operations over a designated "congested area", the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision under which the aircraft is to be operated; and,

WHEREAS, the Borough of Sea Girt is designated as a "congested area" by the Federal Aviation Administration and the County has requested that this governing body consent to its proposed aerial dispensing operations.

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Sea Girt hereby authorizes the Monmouth County Mosquito Control Division or its agents to apply pesticides by aircraft for mosquito control in certain areas of the Borough of Sea Girt designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard or both with the understanding that: after notifying the Borough of Sea Girt Police Department prior to each and every application a minimum of seven (7) days prior to the commencement of such operations:

- a. The County shall utilize pesticides, application equipment and aircraft that are approved for aerial application by the applicable Federal (USEPA) and State (NJDEP) agencies; and,
- b. Such operations will be performed in compliance with applicable Federal and State regulations; and,
- c. The County will notify the Police Department of each municipality over which aerial pesticide operations are planned at least seven (7) days prior to commencement of such operations.
 - R-13-2023: Appoint SMRSA Representative Michael Meixsell

WHEREAS, the Boroughs of Belmar, Brielle, Lake Como, Manasquan, Spring Lake, Spring Lake Heights, Sea Girt and the Township of Wall (collectively the "municipalities") previously adopted a parallel ordinance (the "Ordinance") establishing the South Monmouth Regional Sewerage Authority (the "Authority") and in accordance with *N.J.S.A.* 40A et al; and,

WHEREAS, pursuant to the provisions of the statue and consistent with the Ordinance, each of the member municipalities are to appoint one individual to serve as a Commissioner of the Authority; and,

WHEREAS, the Borough Council of Sea Girt has determined that Michael Meixsell shall be appointed to serve as a member of the Authority from February 1, 2023 to January 31, 2028, inclusive, and until his successor be duly appointed.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Sea Girt that Michael Meixsell be and he is hereby appointed to serve as a Commissioner of the Authority in accordance with the terms set forth in the Ordinance and the by Laws of the Authority.

3. OPEN DISCUSSION -

Mayor Fetzer addressed the many concerns regarding the proposed offshore wind activity and whale washing ashore in our area. Council President Anthony asked for a motion to support coastal mayors unite in calling for a moratorium on all offshore wind activity until investigations are held. **UPON MOTION** of Councilwoman Richman, seconded by Councilman Perry, carried, that the following **R-28-2023** be and the same is hereby adopted:

WHEREAS, the Governing Body of the Borough of Sea Girt is calling for immediate suspension of all offshore wind development activity until a comprehensive, thorough investigation is held by Federal and State agencies that confidently concludes these activities are not a contributing factor to recent whale deaths; and

WHEREAS, the marine mammal population has seen more than seven tragic deaths of whales on the coasts stretching from New York to New Jersey in a brief period of time; and

WHEREAS, the Sea Girt Borough community supports clean energy programs, but seeks to first fully understand the cause of these tragic deaths and what can be done to prevent future losses; and

WHEREAS, the Governing Body of the Borough of Sea Girt are of the opinion that offshore activity should be suspended pending further research as to the potential impact such activity has on whales and other marine life; and

BE IT FURTHER RESOLVED, the Governing Body of the Borough of Sea Girt shall share its expression by forwarding a copy of this Resolution to all members of the United States House of Representatives and United States Senate representing The Borough of Sea Girt and representing the State of New Jersey.

BE IT FURTHER RESOLVED that Governing Body of the Borough of Sea Girt shall also share this Resolution with the Members of the New Jersey State Senate and the New Jersey General Assembly.

Mayor Fetzer discussed the consideration of an ordinance establishing procedures and standards regarding deployment of small wireless facilities in public right of way in the municipality. Councilman Downey commented he is in support of additional consideration and communication of the ordinance. Mr. Gant further commented 5G is developing technology and this ordinance will allow the borough to be proactive communicating between utilities and municipalities. Borough Attorney, Ray Bogan noted we have the ability to create conditions within the ordinance. Councilman Perry commented this ordinance would formalize the process of communication and put the onerous back on the utility company.

5. NEW BUSINESS

A. Introduction - Ordinance No. 01-2023: The Mayor to read the said Ordinance by Title:

AN ORDINANCE TO AMEND CHAPTER XIX, TREE PRESERVATION AND REMOVAL AND SETTING THE REQUIREMENTS FOR SAME IN THE BOROUGH CODE OF THE BOROUGH OF SEA GIRT, MONMOUTH COUNTY GIRT, MONMOUTH COUNTY

19-1 PURPOSE.

[Ord. No. 18-2018]

The purpose of this chapter is to prevent indiscriminate, uncontrolled, and excessive destruction, removal, and clear cutting of trees upon lots and tracts of land within the Borough of Sea Girt in order to maintain the aesthetic character of the Borough of Sea Girt, prevent erosion, and control actions that will substantially change drainage patterns, and restrict actions that will cause a hazard to persons or property.

§ 19-2 DEFINITIONS.

[Ord. No. 18-2018]

As used in this chapter:

CLEAR CUTTING

Shall mean the removal of all standing trees on a site or portion of a site.

COMPETENT PUBLIC AUTHORITY

Shall mean the members of the Shade Tree Commission, the Code Enforcement Officer, Borough Engineer, members of the Sea Girt Police or Public Works Departments, or a N.J. Certified Tree Expert.

CONSTRUCTION

Any development on the property that requires a zoning permit, construction permit, or combination thereof.

DIAMETER AT POINT OF MEASURE (DPM)

Shall mean the diameter (caliper) of a tree at a point on the tree 54 inches above the actual ground level.

EMERGENCY

Shall mean any unforeseen circumstance or occurrence, the existence of which constitutes a clear and immediate danger or hazard to person or property as determined by a N.J. Certified Tree Expert or competent public authority (Borough Engineer);

PUBLIC RIGHT-OF-WAY

Shall mean any street or road shown upon a map or plan filed in the Monmouth County Clerk's office or on the Official Map of the Borough of Sea Girt.

REMOVAL

Shall mean the actual removal of trees, or direct or indirect actions resulting in the effective removal of trees through damage or poison, or similar actions directly or indirectly resulting in the death of trees subject to the provisions of this chapter. Moving a tree to a different location on the same property does not constitute removal. Removal shall not include pruning for maintenance purposes.

SIGNIFICANT SPECIMEN TREES

Shall mean any tree with a diameter at point of measure exceeding 60% of that of the largest similar tree listed in either the Monmouth County's Largest Trees, prepared and annually updated by the Monmouth County Shade Tree Commission or New Jersey's Big Trees, prepared and updated bi-annually by the Division of Parks & Forestry of the New Jersey Department of Environmental Protection.

SITE

Shall mean any lot, tract, parcel or parcels of land within the Borough.

TREE

Shall mean any living deciduous or evergreen tree with a single trunk at a height of one foot above the root crown, with a normally anticipated mature height of 30 feet or greater (including, but not limited to: Norway; Silver and Sugar Maple; Sweetgum; London Plane; American Sycamore; White and Red Pin Oak; American Elm; Yellow and White Poplar; Copper Beech; Cedar; Spruce; Pine; and Fir).

TREE REMOVAL PERMIT

Shall mean a certificate issued by the Borough to remove trees as defined in this chapter.

UNDISTURBED AREA

Shall mean an area in which trees, shrubs, and understory will not be disturbed by filling, cutting or by any other means.

§ 19-3 TREE REMOVAL PROHIBITED.

[Ord. No. 18-2018]

No person shall remove, or cause to be removed any existing trees with a diameter of six four inches or greater caliper at point of measure, upon any lands within the Borough of Sea Girt without a tree removal permit except as follows:

- a. Trees that are to be removed as the direct result of a development application that has been approved by the Borough of Sea Girt Planning Board;
- b <u>a</u>. Any trees cut or removed in accordance with a management plan developed by the New Jersey Department of Environmental Protection, Bureau of Forestry, filed with the Construction Official of the Borough;
- e <u>b</u>. Trees directed to be removed by municipal, County, State or Federal authority. No person shall remove any tree growing on or over a public right-of-way or public land without the express written consent of a competent municipal authority (Code Enforcement Officer, Borough Engineer, etc.) or Shade Tree Commission.

§ 19-4 TREE REMOVAL PERMIT.

[Ord. No. 18-2018]

A Tree Removal Permit shall be required for the removal of any trees of six four inches or greater caliper at point of measure, as follows:

- a. Trees that are dead, severely damaged by natural causes or accident to the point that the natural habit of the tree cannot be restored as determined by a N.J. Certified Tree Expert or competent public authority trees that are severely diseased and require removal as certified by a N.J. Certified Tree Expert; or trees that pose an imminent public safety hazard as determined by a N.J. Certified Tree Expert or a competent public authority (Police, Department of Public Works, Borough Engineer, etc.).
- b a. An application for zoning approval for the construction of new residences, additions to residences in excess of 300 square feet, or, the construction of swimming pools, or other accessory buildings, or structures improvements for the zoning permit or to the Planning Board for a variance shall include an inventory of all trees on the site. Such trees shall clearly be shown on the construction application plans and identified by size and the removal of same shall be limited to no more than 30% of the total number of trees on the site and shall, in the opinion of the Construction Official or his designee, clearly be necessary for the construction of the subject building or structure. If no trees are to be removed as part of the improvement, then a permit shall not be required.
- c. Trees required to be removed subject to a construction permit as issued by the Construction Official for construction of new residences, additions to residences in excess of 300 square feet, or the construction of

swimming pools or other accessory buildings or structures that are not the subject of Planning Board application approvals. Such trees shall clearly be shown on the construction plans and identified by size and the removal of same shall, in the opinion of the Construction Official or his designee, clearly be necessary for the construction of the subject building or structure.

d. Trees removed by a property owner on his own property where no building permit for a new or replacement principal structure is sought.

§ 19-5 TREE REMOVAL PERMIT REOUIREMENTS.

[Ord. No. 18-2018]

- a. Application Form. An application form can be obtained from the Code Enforcement Officer or Borough Clerk and shall include the following information:
- 1. Name and address (street and lot and block) of the owner of the premises and status of legal entity (individual, partnership, corporation).
- 2. Description of the premises where removal is to take place, including lot and block numbers, and street address as assigned if different than the address of the owner.
- 3. Purpose of tree removal.
- 4. In addition to the application form, a survey showing the approximate location and size of all trees with a diameter at breast height of six four inches or greater caliper that exist on the lot, and identifying those trees to be removed. At the discretion of the Code Enforcement Officer or his/her designee, other appropriate documents may be substituted if a survey is not available.
- 5. If a tree is removed under the requirements of Section 19-3 or Section 19-4 paragraph b., e., or d., a mitigation plan must be submitted and approved by the Code Enforcement Officer or his/her designee prior to the issuance of any permit that will provide for the replacement of at least 1/2 of all removed trees by planting a tree of three inches to 3-1/2 2 ½ inches caliper or remitting a fee to the Borough of Sea Girt in the amount of \$500 per tree removed. in accordance with the following:

Tree Replacement Fund Requirements

Size of Each Tree Removed Replacement Trees Value

4 Inches but not more than 6 Inches \$500.00 6 Inches but not more than 10 Inches \$750.00 10 Inches but no more than 16 Inches \$1,000.00 16 Inches or Greater \$1,500.00

b. Trees on a property line requested to be removed shall require written consent of adjoining property owners prior to any approvals or removal.

§ 19-6 FEES.

[Ord. No. 18-2018]

- 1. Upon the filing of an application with the Code Enforcement Officer for a tree removal permit under the terms of this chapter, the applicant shall pay an application fee of \$50 for any trees removed. No fee is required for a tree removed under Section 19-4 paragraph a.
- 2. The applicant may elect, in lieu of planting replacement trees, to pay to the municipality a sum of money

as set forth in Subsection 19-5.5 for each tree required to be planted pursuant to this subsection for the purpose of planting trees and maintenance elsewhere in the Borough. Said funds shall be deposited into the Tree Replacement Fund.

- 3. Tree Replacement Fund.
- a. Where an applicant chooses to make a contribution to the Tree Replacement Fund in lieu of physically replacing the trees on said property as provided in 19-5.5, the amount of said contribution shall be as set forth in 19-5.5. The Tree Replacement Fund shall be in a separate fund with the dedicated purpose of tree replacement and maintenance within the Borough of Sea Girt

§ 19-7 PERMIT APPROVAL.

[Ord. No. 18-2018]

- a. Time Limits for Action.
- 1. The Code Enforcement Officer or his/her designee shall act on an application for a tree removal permit within 30 business days of the receipt of a complete application. Failure to act within 30 days shall be deemed to be an approval of the application and thereafter, a tree removal permit shall be issued.
- b. Duration of Permits.
- 1. If granted for a lot or parcel of land for which no building permit is required, three months from the date of issuance.
- 2 1. If When granted for a lot or parcel of land for which a building or zoning permit is required but for which no variance, subdivision, or site plan approval is required or has been approved by the Planning Board, until expiration of building permit granted with such tree removal permit. permit shall remain open until applicant requests close out.

§ 19-8 COMPLETION.

[Ord. No. 18-2018]

- 1. The holder of a tree removal permit shall notify the Code Enforcement Officer when the tree removal has been completed. The Code Enforcement Officer shall review all cut trees and compare with application. Any deviations to the prior approval shall have the application modified, and any change in replacement tree planting or replacement fund requirements shall be identified and acknowledged by the applicant.
- 2. Upon construction project completion, a review of the application, replacement plan application, and an on-site review of all trees planted on the property shall be reviewed by the Code Enforcement Officer to ensure compliance.
- 3. No Certificate of Completion, Certificate of Approval, or Certificate of Occupancy from the Zoning Official or Construction Official shall be issued until all requirements of the replacement plan have been met

19-9 Removal Requirements

- 1. No tree or portion thereof shall be permitted to be felled, dropped, or further cut within the public rightof-way
- 2. <u>Upon approval, the applicant shall not have any stumps, roots balls, or tree remains on the property for more than 30 days.</u>

§ 19-9 <u>19-10</u> SIGNIFICANT SPECIMEN TREES.

[Ord. No. 18-2018]

It is presumed that Significant Specimen Trees should only be removed in the most compelling and extraordinary circumstances. Removal will be permitted only after approval by a Hearing Panel, as described in Section 19-10 19-11. The loss of lot yield, building area, or profitability of developmental layout shall be deemed neither compelling nor extraordinary.

§ 19-10 19-11 APPEALS.

[Ord. No. 18-2018]

Whenever any application for a tree removal permit shall be denied by the Code Enforcement Officer or his/her designee, the applicant may appeal the denial to the Borough Administrator by filing a written notice of appeal with the Borough Clerk within 10 days after receiving notice of the denial. Upon receipt of the notice of appeal, the Borough Administrator shall appoint a hearing panel consisting of three members: The Borough Engineer, an employee of the Department of Public Works, and any other designee of the Borough Administrator. This panel shall proceed to hear the appeal upon notice to the applicant within 30 business days of the filing of such notice of appeal. This panel shall have the discretion, after interviewing both the applicant and the Code Enforcement Officer or his/her designee, to reverse, affirm, or modify the aforesaid decision.

§ 19-11 19-12 PROTECTION OF EXISTING TREES.

[Ord. No. 18-2018]

In connection with any construction, subsequent to tree clearing but prior to the start of other construction, snow fencing or other protective barrier acceptable to the Construction Official and/or Borough Engineer, shall be placed around trees that are not to be removed. The protective barriers shall be placed at the dripline or canopy line of any tree and shall remain in place until all construction activity is terminated. No equipment, chemicals, soil deposits, or construction materials shall be placed within any area so protected by barriers. Any landscaping activities subsequent to the removal of the barriers shall be accomplished with light machinery or hand labor.

§ 19-12 19-13 EMERGENCY ACTION.

[Ord. No. 18-2018]

In the event of an emergency, trees that pose an imminent public safety hazard as determined by a N.J. Certified Tree Expert or a competent public authority (Police, Department of Public Works, Borough Engineer, etc.), shall have the authority to have such tree removed without requiring that the property owner first apply for a permit. However, the property owner or the designee of such person shall apply for a tree removal permit not later than the end of the second succeeding business day after any regulated activity takes place and may not proceed with non-emergency work including restoration until a permit is obtained.

§ 19-13 19-14 PENALTIES.

[Ord. No. 18-2018]

When regulated trees are removed without a tree removal permit, the affected areas shall be replanted as required by the Code Enforcement Officer or his/her designee. Any such replanting shall be in accordance with the requirements of development regulations. Any person found guilty of violating any of the provisions of this chapter shall be subject to a fine not exceeding \$1,000 \$2,000 as determined by the Shade Tree Commission, per removed tree. Each tree removed or destroyed in violation of this section shall be considered a separate violation.

UPON MOTION of Council President Anthony, seconded by Councilman Downey, carried, that the said Ordinance No. 01-2023 be and the same is hereby adopted on first reading, directing the Clerk to post and publish as required by law and setting the date of the public hearing as March 8, 2023.

• R-16-2023: Authorize Final Payment to Allied Construction Group - \$7,391.56

UPON MOTION of Councilman Perry, seconded by Councilwoman Richman, carried, that the following Resolution be and the same is hereby adopted:

WHEREAS, the Borough of Sea Girt awarded a contract in the amount of \$326,850.00 to Allied Construction Group, Inc., Parlin, NJ for the Project known as Sea Girt Water Treatment Plant Miscellaneous Improvements; and,

WHEREAS, field changes resulted in a net decrease in the contract in the amount of \$10,380.00 to the project; resulting in the new contract total of \$316,470.00; and,

WHEREAS, the Project is completed and the Contractor has submitted the Request for Final Payment in the amount of \$7,391.56 and the required Maintenance Bond of \$326,850.00 that has been reviewed by the Project Engineer and found to be correct.

NOW, THERFORE, BE IT RESOLVED, by the Council of the Borough of Sea Girt as follows:

- 1. That Change Order and Supplemental Agreement representing a net decrease to the contract \$10,380.00 to a new contract total of \$316,470.00 be and the same is hereby approved;

6. COUNCIL REPORTS

Councilman Clemmensen attended The Light House Citizen Committee meeting and they will be starting their membership drive; tours will resume April 16^{th.} He noted today is National Crossing Guard Appreciation Day; he asked everyone to say thank you to a crossing guard for all they do. He asked not to be concerned with the sirens coming from the NGTC, it is part of the recruit class training. The Police Department offers residents to check on their homes while vacant. Residents should have received their borough calendar; please get one at the borough hall or DPW; Recycling Yard is closed the next two Mondays; the following Tuesday will be all zone pickup; February 27th is winter garden pickup and again March 20th and 27th. Please refer to the borough calendar for important dates on trash.

Councilman Downey reported he met with the sewer commission and discussed a well is coming to the end of its life cycle and the committee is reviewing the lifecycle; also noted a led service line inquiry discussion on standards; a rate study was introduced and will continue discussions; grease straps were also discussed and the potential need for an ordinance review. DEP inspection was successful. He congratulated Michael McArthur on obtaining his Certified Public Manager Certificate; congratulations also to Trevor Palmer on obtaining his certification and becoming our Recycling Coordinator; Megan Thompson is currently obtaining her CFO Certification. Employee reviews will be conducted during March.

Councilman Perry reported for Recreation Commissioner Mike D'Altrui that the Polar Plunge was another success spite being the coldest day of the year thus far; 400 registered plungers raising \$40,000 for the Lift Fund Program; he thanked councilmembers, Monmouth County Commissioners, borough staff and all the volunteers for their efforts including Rod's for the post party gathering. Yoga is offered at St. Uriel Church, please visit our website for additional information. Rec desk is the borough's new registration system for all borough activities; paddle clinic registration is underway for both youth and adult instruction.

Councilwoman Richman reported also on behalf of Councilman Zakin noting he attended the Elementary School Strategic Planning Meeting which is focused on mutual communications and interactions within the community and sending districts; he thanked the community who contributed to the great effort put forth by our ordinance review committee on amending the tree ordinance. Mr. Zakin supports coastal mayors unite in calling for a moratorium on all offshore wind activity; he wants to assure that we take reasonable steps to ensure the protection of the public and the environment before plans for offshore winds are finalized.

Mr. Gant also reported for Councilman Zakin that he was pleased to report the results of the Library Board of Trustees Strategic Planning Committee; over 450 members participated to help create this plan which can be found on the borough and the library website; some challenges to our community include assessing options for learning and personal growth, keeping up with technology, reliable health information and safeguarding against identity theft. Top concerns regarding government for the public: fiscal responsibility, open communication and value input from residents/government transparency.

Council President Anthony noted The Holly Club will be doing the screening of the Wild in the Garden State movie on March 2^{nd} beginning at 7:00 pm at the Sea Girt Elementary School; The Sea Girt Conservancy will also have a panel regarding the Pollinating Garden on March 23^{rd} from 6-9 pm.

Mayor Fetzer commented the library is moving along with enthusiasm and energy. He welcomed and thanked Mike Meixsell on his appointment to SMRSA. Coffee with the mayor will resume in February, May, August and November.

7. ADMINISTRATIVE REPORT

Mr. Gant reported he was notified by JCP&L that tree trimming work will be conducted in March on their service lines; they will need access to utility right of ways. Budget preparations are underway for 2023. He noted a Department Head meeting was held earlier which is a great collaboration between department heads.

Police Chief Macko recognized David Galarza for participating in the Polar Plunge; he thanked the crossing guards for their work which sometimes goes unnoticed, but they take their jobs very seriously and we are grateful for them. The SLEO's are currently still in the academy and will finish before Memorial Day; Class I's will be appointed at the March 8th meeting. The speed trailer located on Washington Boulevard has been successful, if anyone would like it relocated, please contact the police department. The Police Department also had a Department Head meeting at the NGTC discussing 2023 goals.

9. PUBLIC PARTICIPATION ON ANY SUBJECT

She thanked the Sea Girt Conservancy for all their efforts and their wonderful work in the community.
